# **Golf Cart Rental Terms**

The Parties to this Terms are:

Golf carts must be returned by 10:00am on the final day of rental. If the golf cart is scheduled to be picked up by the Owner, the golf cart must be made accessible no later than 9:00am on the final day of rental. If the golf cart is not accessible for any reason, a convenience fee of \$25.00 will be added. If the golf cart is not accessible by 3:00pm on the final day of rental, another full day rental fee will be added and pick up will be scheduled for the following day.

## Pickup and/or Delivery Option:

The Renter has the option of pickup and/or delivery and agrees to pay the Owner the rate of <u>\$25.00</u> for pickup and/or delivery of the below-described golf cart(s). Pickup/Delivery rate is \$25.00 plus \$2.00 per mile. Delivers are pending approval depending on dates & times. Fees may also be adjusted due to special circumstances (i.e.: location or multiple units).

## Deposit:

Upon approval of order, a NON-Refundable \$100 deposit will be charged the card on file. The Renter further agrees to provide a valid Credit Card information on file. Renter agrees he/she is solely responsible for any damages incurred during the term of this rental agreement. Rental is to be paid for in its entirety before cart leaves Southeastern Carts LLC. Renter authorizes Southeastern Carts LLC Co. to charge the credit card on file in the event there are any damages to the vehicle.

## Waiver of Liability & Indemnity Agreement:

By signing this Agreement, you (the Renter) are FULLY AND TOTALLY liable for any and all injuries, to yourself and/or anyone that is riding or has ridden the golf cart(s). You are also responsible for any and all medical expenses, emotional damage, diagnosis, and treatments to/for yourself or any third party injured as a result of your action while the aforementioned golf cart(s). You waive any and all claims against Southeastern Carts LLC Co., LLC (should it be necessary).

Indemnification and Hold Harmless: I also agree to DEFEND, INDEMNIFY AND HOLD HARMLESS the Owner, its members, officers, employees and agents, from and against any and all claims, demands, actions or causes of actions, for costs, attorney's fees, expenses or damages to personal property, or personal injury, or death, which may result from any use of the cart(s).

## TERMS AND CONDITIONS:

- No one under the age of <u>18</u> or without a valid driver's license is authorized to operate this golf cart.
- The rented golf cart shall not be used to carry passengers or property for hire.
- The rented golf cart shall not be used to carry passengers in excess of the capacity stipulated above.
- The rented golf cart shall not be used to carry passengers, goods or materials in excess of the rated passenger/weight carrying capacity of the golf cart as stipulated above.
- The rented golf cart shall not be used to push, pull, or tow anything without the written permission of the Owner.
- The rented golf cart shall not be used for any illegal purpose.
- The Renter shall not operate the golf cart in a negligent manner.
- The rented golf cart shall not be operated by any other person or persons other than the Renter(s) stipulated above without the express written permission of the Owner.
- The Renter shall not remove the motor from the golf cart for any use whatsoever.
- No passengers shall be carried on the golf cart while the golf cart is being towed by the trailer

## Compliance with Law:

Renter is solely responsible for abiding by local and state laws regarding use of the golf cart. In the event that Owner is required to pick up the golf cart from impound, the Renter acknowledges that the Renter is solely responsible for all fees associated with the violation. Credit card on file will be charged for all fees as well as an emergency pick up fee of \$150.00.



### **Qualifications:**

The Renter states that he/she is physically and legally qualified to operate the above-described golf cart(s).

### Insurance:

The Renter hereby agrees that he/she shall be held fully responsible for any and all loss of, or damage to the golf cart, equipment or motor during the term of this Agreement, whether caused by collision, fire, flood, vandalism, theft or any other cause, except that which shall be determined to be solely caused by a fault or defect of the golf cart, equipment, or motor.

### **Conditions of Golf Cart:**

The Owner states that to the best of its knowledge and belief, that the above-described golf cart(s) is in sound and safe condition and free of any known defects or faults which would affect its safe and reliable operation under normal use.

## Additional Terms:

Weekend rentals are a minimum two-day rental (as we are closed on Sundays; holiday weekend rates are subject to change). Rates vary depending on size of cart and length of rental, see below. Commercial rates may vary, please contact our sales associates for details.

A valid credit card will be held on file in lieu of deposit (debit cards and preloaded/prepaid cards will not be accepted for this purpose). Payment for rental must be received prior to cart(s) leaving Southeastern Carts LLC. Cancellation of a rental with 24 hours of a rental will result in forfeiture of the reservation deposit.

A NON- Refundable deposit must be paid to hold your reservation.
